In a shocking new development in the case of Savannah Craven Antao, the young pro-life advocate who was punched in the face on video during a peaceful “woman on the street” video in Manhattan, District Attorney Alvin Bragg’s office has doubled down on its refusal to prosecute her assailant, Brianna Rivers, even after Thomas More Society attorneys presented evidence showing that prosecution was still legally possible.

DA Bragg has embarrassed the entire black community with his level of legal incompetence. He should fire someone for this level of malfeasance.

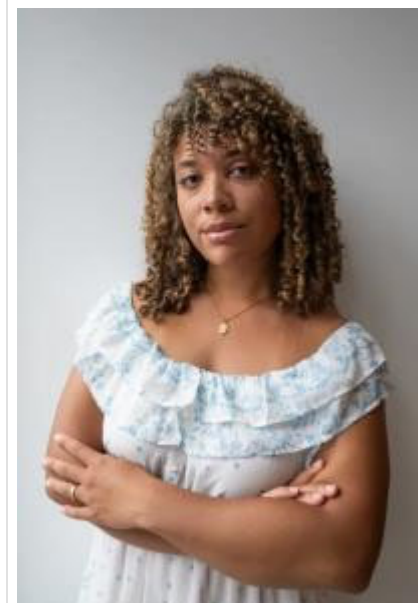
