president of the United States when serving in an official capacity of the United States Government.

The Rev. Anthony Evans, President of the National Black Church Initiative says, "We recognize a disturbing pattern on the part of President Trump. He is systemically attacking black women. He has fired over 300,000 low-level black women employees, and now he is going after high-level black women in and outside of government. I

have authored a full-scale public nonviolent defense of Mr. Trump's actions toward Black women. The Black Church loves Black women, and we will do everything, and I mean everything in our power to protect

them and their dignity."

Due process of law refers to the state's application of all applicable legal rules and principles in a case, so all legal rights owed to a person are respected. Due process balances the power of the law of the land and protects individuals from its effects. Accordingly, to many legal experts, the

President does have the power to fire anyone, but only with cause, as defined by the country's employment laws. The Black Church has a long history of fighting for the rights of black people, and we will not stop because President Trump decided to try to bully Gov. Lisa Cook. We will not stand by and allow this to happen to any of God's Children who are daughters of Africa and citizens of our great democracy, but we cannot be great without providing everyone their due process under the Law.

The allegations against Gov. Lisa Cook have not been thoroughly investigated. President Trump is rendering a verdict without hearing one piece of evidence.

The New York Times reports that President Trump announced on Monday night that he was removing Federal Reserve Board member Lisa Cook for "cause" — a claim that she committed mortgage fraud that was referred to the Justice Department but has yet to be proven in the judicial system.

Yet the allegation is in some ways an echo — albeit in miniature — of what Mr. Trump was found liable for in a New York civil case in 2024.
